- 2) Only the Lecture and Test portion for the 3rd Class International Master Course is currently available. The 1st and 2nd Class Online Lecture and Test will be available soon.
- 3) International Master Certification candidates who have successfully completed the Online Master Theory Course must still participate in full at the In-person Master Course.
- 4) Those who passed the Online Test do not need to take the In-person Written Test.
