## Grounds for Kukkiwon Presidential Election Candidate Disqualification

Grounds	Contents	Comments
「Act on the promotion of Taekwondo and creation of Taekwondo Park」 Article 19(6)	Persons falling under any of the subparagraph of Article 33 of the 「State Public Officials Act」	
「The Articles of Association of Kukkiwon」 Article 12(1)	Minors	
Article 12 paragraph 3 subparagraph 1	Persons who have committed crimes prescribed in Articles 355 or 356 of the Criminal Act with respect to performance of duties during their term of office in Kukkiwon or an organization they were affiliated with and, as a result, have been sentenced for a fine of no more than KRW 3 million with five (5) years not having passed after the final decision of their punishment being rendered, or have been sentenced for a fine of no less than KRW 3 million with the final decision of their punishment being rendered	
Article 12 paragraph 3 subparagraph 2	Persons who have been subjected to disciplinary action of no less than one (1) year suspension of qualification by a governmental agency, sports organization, or any other organization, but for whom five (5) years have not passed from the date of expiration of the disciplinary action (however, where a person has been subjected to disciplinary action of no less than one (1) year suspension of qualification by a governmental agency, sports organization, or any other organization because of their manipulation of game results, violence or sexual violence, embezzlement, breach of trust, or biased judgement, they may never be appointed as an executive.)	
Article 12 paragraph 3 subparagraph 3	Persons who have been dismissed or expelled by a governmental agency, sports organization, or any other organization because of their unlawful activities of manipulation of game results, abuse of position, etc. or disciplinary actions taken for negligent performance of duties, designation of controlled association, etc.	
Article 12 paragraph 3 subparagraph 4	Persons who have committed crimes prescribed in Article 314 of the Criminal Act or Articles 47 or 48 of the National Sports Promotion Act by engaging in manipulation of game results affecting the results of matches hosted by a governmental agency, sports entity, or any other entity, and, as a result, have been sentenced to no less than a fine with the final decision of their punishment being rendered	
Article 12 paragraph 3 subparagraph 5	Persons who have been sentenced to no less than a fine for driving while intoxicated (according to 「Act on the lapse of criminal sentences」 Article 7)	Applicable only to cases that occurred after May 13, 2019, pursuant to Articles
Article 12 paragraph 3 subparagraph 6	Those who have been punished or dismissed in regard to the Poom and Dan Promotion Tests of Kukkiwon	of Association Subparagraph 9, Annex Article 3
「The Regulation on Presidential Election」 Article 18	Persons who have not resigned from below positions within ten (10) days of the date that the ground for holding the by-election was confirmed Executives or employees of Kukkiwon, World Taekwondo, Korea Taekwondo Association, Taekwondo Promotion Foundation, Kukkiwon Taekwondo 9 <sup>th</sup> Dan Holder Federation, Korea Taekwondo Association for the Disabled and Korea Women Taekwondo Federation.
